The pool rental fee for private parties is \$200 for 3-hours. Party size is limited to 100 people. Rental fee includes one guard and a pool employee with a Pool Operators License (POL) as required by Douglas County. If additional guards are needed, the cost is \$50/guard. If Private Pool Parties go past the allotted block of time, the member will lose their \$100 deposit and additional guard/POL fees may apply. All parties with alcohol are subject to approval by the Westridge Pool Board. If Alcohol is served appropriate and reasonable precautions must be used to prevent underage drinking. Additional terms may include, but are not limited to, increasing the cost, placing restrictions on kegs, or require the presence of a security guard or Pool Board member. A Pool Board member will be on-call during parties at which alcohol is served. No private pool parties after hours on Sundays.
